You will receive correspondence via mail of setup or change of your automatic payment.

If the draft date selected falls on a weekend or bank holiday, the debit will occur on the next business day. The selected draft date does not change the payment due date or grace period provided in your loan documents.

Insufficient funds may incur a return payment fee or late charge as permitted by your loan documentation and applicable law.

This authorization to initiate a debit from the account listed will remain in full force and effect until Guardian receives written notice from the undersigned of its termination at minimum four (4) business days prior to the next scheduled draft date, or in such manner and time frame as to afford Guardian opportunity to act upon it. This form must be **physically signed - electronic signatures will not be accepted unless directly authorized and initiated by Guardian.**
